
A Message From the CEO

I am proud to say that Tabor has emerged stronger and remains even more committed to serving our communities at a time when the need is greatest. Our ability to sustain a growth trajectory reflects this, as does Tabor's continuing recognition as a child welfare leader across Philadelphia, Chester, Bucks, and Montgomery Counties.

In addition, we are proud to have collaborated with Woods Services on a RFP from Chester County Department of Mental Health Intellectual & Developmental Disabilities (MH/IDD) to provide comprehensive system of care services for children and adolescents (ages 5-21) at risk for out of home placement in Residential Treatment Facilities (RTFs), Community Residential Rehab (CRR) Host Homes, and substance use non-hospital rehab facilities as well as children in juvenile justice placements in need of mental health and/or substance use services while in placement or upon discharge from placement.

Tabor has also been invited to apply for Youth Mentoring and Independent Living Services (IL) to current and former youth who were placed into foster care between the ages of 14-23 years. This includes aftercare services, which are defined as IL services available to any youth who exited foster care on or after their 14th birthday and before their 23rd birthday. So, Tabor has a lot to celebrate if these possibilities translate to new opportunities.

Tabor's size and scale place us in a unique position to help change the world for the better. Our distinctive culture is built on a foundation of quality, ethics, and integrity which is at the core of each decision we make. As we continue to expand on Tabor's 117-year legacy of making an impact that matters, we see a bright future.
